We've also seen strong increases in Big Law employment – with roughly 25% of the classes of 2024 and 2025 taking jobs at large law firms.

As one of the nation's top public law schools, we keep tuition low, and 100% of admitted students receive a scholarship. Non-resident scholarship recipients may be eligible for a non-resident tuition waiver, which allows them to pay tuition at Texas resident rates.

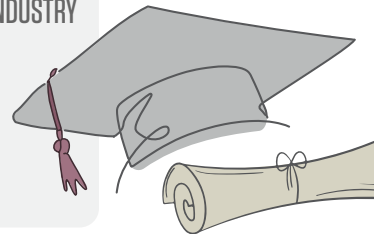
